

### 9/11 Hard Core

The Sarasota police in turn notified the Secret Service. Notice the time: 0407 hundred hours. The intrigue continues. ### Foreign Penetration Agents?

"Angel is target." Before dissecting the obvious significance of this phrase let's put it into perspective. First there is the middle-of-the-night threat to President Bush, rapidly followed by another assassination attempt by an apparently bogus television crew ala Shah Massoud, the two WTC buildings are leveled along with the attack on the Pentagon. And now for the bad news. Just when President Bush and his entourage are spirited aboard Air Force One the "Angel is target" threat emerges. This is the quintessential bad day.

Clearly some individual, or team, with access to super-highly classified secrets was involved. With this perspective let's examine some of the catastrophic events from that tragic day. The government's version is obfuscated by layers of deceit and duplicity. To illustrate let's start with WTC Building 7 that collapsed into its own footprint around 5:20 PM. It bears repeating: Fires have never caused the total collapse of a steel-framed high-rise before or since 9/11.

The fire broke out on the 11<sup>th</sup> floor with flames spreading vertically to ignite more fires from the 9<sup>th</sup> floor to the 19<sup>th</sup>. 150 firefighters arrived at the scene; before the conflagration was finally extinguished 28 firefighters sustained injuries from the intense heat and smoke. According to Captain Harold Kull of Engine Co. 6, "It was like fighting a blow torch."



Although the fire lasted over 3 hours, it caused no serious structural damage. Embedded trusses not only survived the




The above image is one of an amazing series of pictures taken by Bill Biggert, a photographer who was reportedly killed by the dust cloud from the WTC-1 collapse. At those eight locations there were four transformers in each substation that weighed over 30,000 lb. The transformers would not explode on their own they were air cooled dry type transformers and yet after the collapse there was no evidence of them being found at the bottom of the towers. Do The Flashes Seen In This WTC-2 Collapse Video Indicate The Detonation Of Cutting Charges?

The above broadcast video of the WTC-2 [the building on the left] collapse has high enough resolution that, when viewed frame by frame, a series of small bright flashes can be seen during the collapse. Most of them last from for only one frame (1/30 sec.) and appear as bright white point sources emanating from the building. At first these might be taken for video noise, but the fact that they only occur in areas occupied by the South Tower and are bigger than a single pixel argues against this.

Louie Cacchioli, 51, a firefighter assigned to Engine 47 in Harlem:

We were the first ones in the second tower after the plane struck. I was taking firefighters up in the elevator to the 24th floor to get in position to evacuate workers. On the

last trip up a bomb went off. We think there was bombs set in the building. On the morning of 9/11 NBC reporter Pat Dawson spoke with Albert Turi FDNY Chief of Safety who said he received word of the possibility of a secondary device, that is another bomb going off. He thinks that there were actually devices that were planted in the building.

When asked about subterranean molten metals Gross responded:

"Let's go back to your basic premise that there was a pool of molten steel I know of absolutely nobody and no eyewitness who said so." – John Gross

So there you have it. According to the NIST no one saw any molten metal.

#### A half-baked farce?

It is an established fact that structural steel from the World Trade Center was cut up and sold for scrap preventing proper forensic investigation of the steel columns. This deliberate destruction of evidence was harshly criticized by professional firefighters. A trade magazine, Fire Engineering, in an article titled \$ELLING OUT THE INVESTIGATION, went so far as to call the investigation of the WTC fires a "half-baked farce."

"Fire Engineering has good reason to believe that the "official investigation" blessed by FEMA and run by the American Society of Civil Engineers is a half-baked farce that may already have been commandeered by political forces ...

"Respected members of the fire protection engineering community are beginning to raise red flags, and a resonating theory has emerged: The structural damage from the

# planes and the explosive ignition of jet fuel in themselves were not enough to bring down the towers.

The article concludes with:

"The destruction and removal of evidence must stop immediately."

An article published in the Switzerland publication *Tages-Anzeiger* points out that, "The steel was recycled in Asia. Professor Frederick Mowrer of the Fire Protection Engineering Department at the University of Maryland, who had to investigate the collapse of the WTC buildings together with other US experts, sharply criticized this approach: 'I find the speed with which important evidence was removed and recycled appalling.'"

In fact the NIST report is riddled with flaws including the specious assertion that high temperatures softened the steel columns and floors. Actually, NIST did conduct tests to determine the temperature of the steel columns in proximity to the fires. The first test, which examined paint deformation on steel samples chosen specifically from the fire zones, showed that less than 2% of the samples had seen temperatures above 250 °C (482 °F). For comparison self-cleaning ovens run for several hours at 900 °F. Does the very thin, one-eighth

inch steel soften and buckle? The melting point of steel is around 1,500 °C. or 2,600 °F. Steel can lose strength at temperatures below its melting point but not at self-cleaning oven temperatures.

Despite the NITS temperature studies that revealed the vast majority of steel did not experience temperature of over 250 °C (482 °F), Dr. Hyman Brown from the WTC construction crew, made the spurious claim that the buildings collapsed due to fires at 2000°F melting the steel. He states "What caused the building to collapse is the airplane fuel . . . burning at 2,000°F."

Steel is a very effective conductor of heat. Consequently the heat of a serious hot spot on one floor, due to tens of thousands of gallons of burning jet fuel, will rapidly dissipate up and down the columns that pass through that hot spot. This means that the steel columns would soon heat up uniformly. The total mass of steel for each WTC building is hundreds of thousands of tons. Is it really believable that the jet fuel of a single jetliner can heat, say, 200,000 tons of steel uniformly to temperatures as high as the melting point of steel?

An article published in the November 2022 edition of *Frontiers* of *Structural and Civil Engineering* sought to determine the "Thermal response of steel framing members in open car park fires."

The extreme right column portrays the average temperature of steel measured determined during the open car park fires. The average temperature ranges from 309°C to 67°C; none of which come close to the melting temperature of steel which is around 1,500 °C (2500°F).

NIST's account of the structural failure of the twin towers depends on a computer simulation based on faulty assumptions deliberately chosen to produce the result. This suspicion arose when NIST refused to release the data input used for their computer simulations for expert scrutiny.

The obvious problem was that steel does not soften or lose significant strength at low temperatures, yet NIST's story depends on the softening or weakening of vast quantities of structural steel. With these concerns in mind Dr. Kevin Ryan, a senior scientist at Underwriters Laboratory, emailed Dr. Frank Gayle the NIST scientist "investigating" the collapse of the WTC buildings. Ryan wrote:

"The summary of the new NIST report seems to ignore your findings, as it suggests that these low temperatures caused exposed bits of the building's steel core to 'soften and buckle'. Additionally, this summary states that the perimeter columns softened, yet your findings make clear that 'most perimeter panels (157 of 160) saw no temperature above 250 °C'. To soften steel for the purposes of forging, normally temperatures need to be above 1100 °C. However, this new summary report suggests that much lower temperatures were be able to not

only soften the steel in a matter of minutes, but lead to rapid structural collapse."

# Searching WTC dust for clues.

Even though the government confiscated the steel beams and sent them overseas for recycling scientists could still search for clues by analyzing the dust collected from the WTC scene. It turns out that highly sophisticated analytical methods can be used to examine WTC dust.

After examining dust particles collected from the WTC grounds physicists from Brigham Young University (BYU) led by Dr. Steven Jones made some startling discoveries.

Using scanning electron microscopy, they found that much of the iron-rich dust was composed of roughly spherical particles very tiny in size. This was an important clue since the presence of metallic microspheres implied that the metals were once molten droplets in which surface tension pulled them into a roughly spherical shape. Afterwards the molten droplets solidified in air on dust particles which were abundant due to massive pulverization.



In 2005 the United States Geological Survey confirmed the existence of iron-rich microspheres in WTC dust with photographs.

But the BYU researchers also discovered another curious feature: distinctive red/gray chips that at first seemed to be chips of paint residue. But careful analysis with electron-microprobe, X-ray Fluorescence, X-ray energy dispersive spectroscopy and differential scanning calorimetry, ruled out that possibility and provided an exciting insight: what were originally thought to be chips of paint embedded on WTC dust particles turned out to be a "highly energetic advanced nanocomposite material."

One of the early observations that led them to consider this novel idea was the observation that when the red/gray chips were heated to about 430° C. (806° F.), they ignited, releasing relatively large amounts of energy very fast.

The gray appearing particulates are aluminum while the red particulates are composed of iron. Iron oxide appears in many-sided grains roughly 100 nm across. The iron oxide and aluminum are intimately mixed in the red material.

Iron oxide and aluminum are the ingredients of classic thermite, an incendiary that burns unusually hot at approximately 4500°F, producing aluminum oxide and molten iron.

Aluminum (powder) + Iron oxide → Aluminum oxide (white plume) + Molten Iron (yellow-white hot)

The chemical equation is written as:

2 Al + Fe2O3 → Al2O3 + 2 Fe (molten iron)

What happens is that the aluminum snatches oxygen away from iron. It is what chemists call an oxidation/reduction reaction and they can generate immense heat. In this case enough to melt solid iron into a molten state. Thermite contains its own supply of oxygen and so the reaction cannot readily be smothered.

Does this explain the hot, long-lasting subterranean fires accompanied with molten iron that were observed for several months after 9/11?

For months after destruction World Trade Center fires at ground zero could not be put out, despite the several inches of dust covering the entire area after the destruction of the WTC buildings; millions of gallons of water were sprayed onto the debris pile; several rainfall events occurred at ground zero, some heavy; and a chemical fire suppressant called Pyrocool was pumped into the pile.

An article published in the peer-review journal *Environment*Systems and Decisions titled Environmental anomalies at the
World Trade Center: evidence for energetic materials states:

"The characteristics of these un-extinguishable fires have not been adequately explained as the results of a normal structure fire, even one accelerated by jet fuel. Using advanced instrumentation, the discovery of thermite residue on WTC dust was a routine matter nonetheless it needs to be independently confirmed since the presence of thermite has immense implications: the three WTC buildings were collapsed with controlled demolition. If so that it opens up a Pandora's box of imponderables.

While working with a team of international collaborators yet another stunning discovery emerged: the thermite discovered on WTC dust particles is not a conventional variety but is a form of super-thermite.


The advantage (of using nanometals) is in how fast you can get their energy out."




