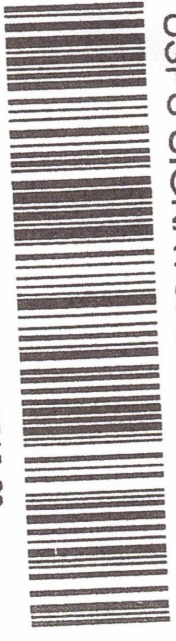

Dear Sir/madam:

This constitutes a formal notice to interrupt the Statute of Limitations under Texas Law to exert a legal action against you for the damages you have caused Targeted Justice Inc., and the undersigned, a/k/a Richard Lighthouse resulting from your reiterated defamatory and libelous conduct.

Ms. Christiana is jointly liable as a joint tortfeasor responsible for the financing of the consistent, varied and intentional defamatory campaigns and mechanisms that Mr. Christiana has perpetrated against both Targeted Justice and Richard Lighthouse and/or Winter Owen Calvert.

The specific defamatory actions that have perpetrated the damages set forth below stem from the following:

2) Email dated approx. 16 September 2022, which was widely disseminated to hundreds, if not thousands of people (to be discovered) titled "Open Letter to Community by Jack Christiana". This email made it throughout the TI community.

3) All other emails, publications and public statements containing false and defamatory facts about Targeted Justice and/or Richard Lighthouse and/or Winter Owen Calvert.

The aforementioned publications have caused Targeted Justice, Inc. substantial damages that include but are not limited to the following: loss of reputation; loss of revenue; distrust in the Targeted Individual community that has interfered with its capacity to carry out its mission. These damages are estimated in an amount not less than FIVE HUNDRED THOUSAND DOLLARS (\$500,000.00)

Aside from defamation, the aforementioned publications also constitute intentional infliction of

emotional distress. They have caused Winter Owen Calvert a/k/a Richard Lighthouse the following damages: anxiety, severe mental pain and suffering resulting from his loss of reputation; distrust within the Targeted Individual community, preoccupation over unfounded persecution and false accusations under the law. These damages are estimated in an amount not less than THREE MILLION DOLLARS (\$3,000,000.00).

As joint tortfeasors, you are both responsible for these damages.

It is in your best interest to mitigate damages immediately to remove from the aforementioned pages any and all reference, comment, or post about Targeted Justice, Richard Lighthouse and/or Winter Owen Calvert.

Furthermore, it is in your best interest to issue and publish retractions and corrections to your defamatory statements enumerated above and those unknown at this time.
